

# Development of the Farndon Parish Council Neighbourhood Plan Terms of reference for The Neighbourhood Plan Committee

#### Introduction

The terms of reference outline the key roles and responsibilities of the main partners involved in the development of the Neighbourhood Plan. The Parish Council, together with Cheshire West and Chester Council are committed to working in partnership to produce an up to date and effective neighbourhood plan for the parish of Farndon. The Plan will seek to identify the needs and aspirations of the whole community and will set out a vision for sustainable growth whilst safeguarding our rural heritage. Resources will be committed as appropriate by all partners, including time, to produce a viable plan.

### Overall aims of Neighbourhood planning

The aim of the neighbourhood planning process will be to provide an opportunity for the community to set out a planning and land use policy framework for the area to enable the achievement of identified local aims and priorities. Its preparation will implement, as far as possible, the provisions of the Governments Decentralisation and Localism Bill

### **Roles and Responsibilities**

The Neighbourhood plan committee will comprise of members of the Parish Council and members of the community who will lead on the development of the Neighbourhood Plan. They will agree, prepare and abide by a community engagement strategy which will engage with the community, key stakeholders and local businesses. They will seek to involve as many members of the community as possible in the process.


The Committee will also liaise with other neighbourhood planning activity being undertaken within Cheshire West to identify and share good practice as appropriate.

The Committee will be chaired by a member of the Parish Council and will report progress to the Parish Council at the monthly meetings of the Council.
