Helsby Parish council hereby declare the intention of applying for designation of a neighbourhood area.

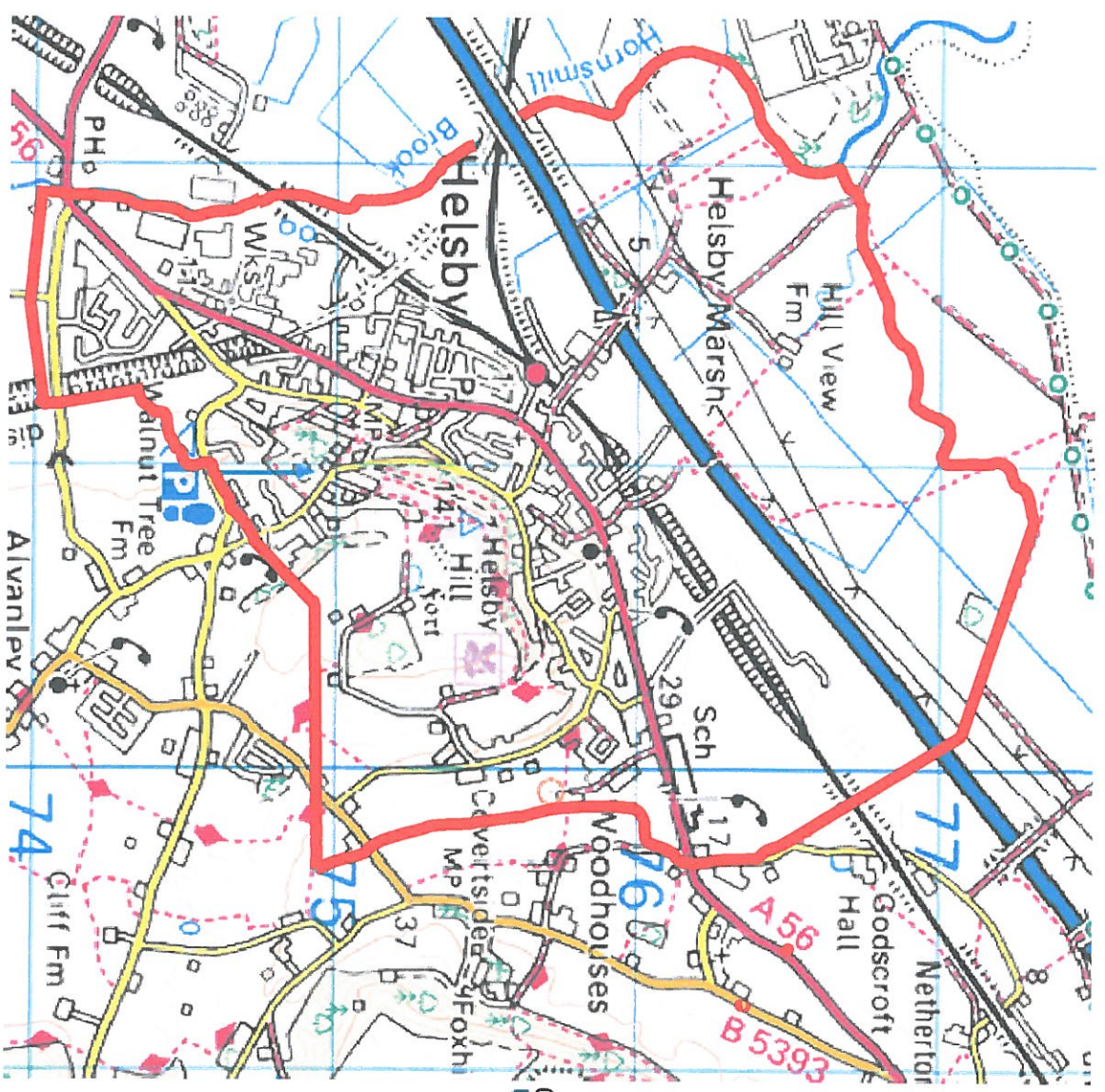
