Local Plan (Part Two) Land Allocations and Detailed Policies

Subject matter and area covered

The Local Plan (Part Two) Land Allocations and Detailed Policies plan was submitted to the Secretary of State for Communities and Local Government on 12 March 2018. The Local Plan (Part Two) provides detailed policies and land allocations, which support the strategic objectives and policies, set out in the Local Plan (Part One) for the period to 2030, and covers the administrative area of Cheshire West and Chester Council.

Examination hearing sessions took place between 18 September and 27 September 2018. Following this the appointed Planning Inspector, Roisin Barrett MSc BSc (Hons) Dip UD Dip Hist Cons MRTPI IHBC, has identified main modifications that are considered necessary to make the plan sound and/or legally compliant. A Sustainability Appraisal of the proposed main modifications and a Habitat Regulations Assessment have also been prepared.

The Inspector is now inviting comments on the main modifications. Comments at this stage should only be made in relation to the main modifications, not other aspects of the Local Plan (Part Two) outside the scope of the main modifications consultation.
