
CHNP Affordable Housing Survey Responses

The term 'affordable housing' is clearly a trick by the Government, so that people don't realise what they really mean is 'social housing.' Social housing would be better provided in areas with easy access to facilities, where people who cannot afford cars can walk to the shops, doctors, etc, without the extra expense of transport. The residents of Clotton Hoofield have worked hard to afford to live in an area of beautiful countryside. To simply give that to others without the need to get a job, would be very demoralising and make them wonder why bother going to work if they can have it for free. The Governments £24

billion social housing bill is unsustainable and the money better spent on getting people into work. The provision of social housing would also create a stark divide in socioeconomic backgrounds. This would only create a split in the community. People of similar socioeconomic backgrounds are better suited living together within their own communities, not forced together to meet government targets.

Infrastructure would have to be reviewed if there were more housing

This will not necessarily address local housing needs if people from outside the village are given the affordable housing and this is not the type of housing required.

Will lower house prices

The introduction of affordable housing could introduce a different demographic that will fundamentally change the community. I acknowledge the need for additional housing but very careful considerations need to be taken.
